

The first is to visit a cemetery and pray for the dead during the Octave of All Saints Day, Nov. 1-8). The second is connected to the Feast of All Soul's Day (Nov. 2), and can be received by those who piously visit a church or oratory on that day and recite the Our Father and the Creed. This year, the Vatican has decreed that these plenary indulgences can be obtained on any day in November to reduce crowds.
